

CredTube Terms & Conditions -Draft

1. Acceptance of Terms

By accessing or using **CredTube** (the "**Platform**"), you agree to be bound by these Terms & Conditions and the Privacy Policy. If you do not agree, you must not register for or use the **Platform**.

3. Account Registration

You must register with a valid email address, such as a personal or business email you control.

Where required, account access must be completed through Google authentication.

You are responsible for safeguarding your login credentials and all activity under your account.

CredTube may suspend or terminate accounts that appear fraudulent, abusive, or otherwise in violation of these Terms.

4. Platform Services

CredTube is a rewards-based engagement **Platform** that may allow users to participate in campaigns, complete actions, and earn credits or other rewards based on eligible activity.

5. Google Authentication & YouTube Interactions

Certain campaigns may require Google authentication to verify user identity and access to connected services.

Authentication is used for verification, authorization, and account-related purposes only.

Users are solely responsible for any actions taken through connected accounts and for complying with applicable platform policies.

Interfere with the normal operation or security of the **Platform**.

9. Suspension and Termination

CredTube may suspend or permanently terminate accounts for:

Violation of these Terms.

Fraudulent activities.
